[The current version of the MAP was due to be formally renewed and revised at an away day in September 2015. However, since the church is without a priest following Dr Alan McCormack's departure on 31 August 2015, any revision must wait until a permanent priest is appointed. Annotations have been made to the 2012 version to indicate what has been achieved, what has been thwarted for whatever reason, and which items are in abeyance until a new priest is appointed. A draft MAP has been prepared under the leadership of the PCC to provide guidance on a continued but limited MAP. PCC members will be considering amendments to the MAP during the interregnum. The original text has been re-formatted into a table to make it easier to follow the amendments.]

<p>The parish of St Botolph without Bishopsgate covers an area around Liverpool Street Main Line Station, as indicated in the attached map and is located within the financial heart of the City of London. The church of St Botolph is situated on the main thoroughfare of Bishopsgate and is within a short walk of Liverpool Street Station, a significant train terminus serving as a focal point of entry and departure for the City of London.</p>

The church location gives rise to two entrances and therefore two approaches to the church: firstly from Bishopsgate and secondly through the churchyard and garden to the south side of the church, where the newly refurbished entrance, completed in 2011, is located which now incorporates wheelchair/disabled access. The inside of the church, as well as the outside, provide a public focal point. Outside there are bench seats, low walls and areas of grass located in the garden creating a welcome lunchtime rendezvous, in good weather.</p>

- in 2007 the Roll was completely renewed; the number of 49 was down from 85 in 2006. The Roll is next due to be completely renewed in 2013, and a dip in numbers may be expected then as well. **[As will be seen the numbers did decrease slightly as expected after the 2013 Renewal.]**

As part of the bringing couples to marriage, or conducting a child baptism, the Rector provides personal direction and counselling which enriches their experience, and has often laid the foundation for confirmation, a regular commitment to attending services and ultimately to additional members on the church Electoral Roll.
